RELEASE, WAIVER OF LIABILITY, COVENANT NOT TO SUE AND LIKENESS RELEASE

(READ CAREFULLY BEFORE SIGNING)

I, _____, hereby acknowledge my awareness that my child’s participation in the Kings Sports Centre Summer Camp may involve activities which include, but are not limited to, the following: stretching, running, jumping, kicking, throwing, swinging, catching, swimming, sliding and bodily contact with other campers and with athletic equipment. It may also involve competitive sports which use various types of athletic equipment which include, but are not limited to, the following: balls, bats, rackets, helmets, cleats, pads, nets, frisbees, goal posts, sticks, pucks and/or other athletic equipment.

I also understand that my child’s participation in the aforementioned activities may expose my child to risks of property damage and bodily or personal injury, including injury that may be fatal, and any one or more of the following: injury from slipping, tripping and falls; sickness; foreseen and unforeseen inclement weather; cuts; abrasions and puncture wounds, broken bones; injury from contact with other campers and from contact with athletic equipment; muscle strains and sprains; concussions; drowning; and heart attack. In addition, I understand that my child may be exposed to other risks which may not be foreseeable. I have been informed by reading the camp description online and understand that there are inherent risks and dangers involved in this activity. I knowingly and freely assume, on behalf of my child, any and all such risks and voluntarily participate in this activity. I understand that it is my responsibility, as the participant’s parent, to allow my child to engage only in those activities which are appropriate.

I acknowledge that my child must follow the instructions of the activity leader at all times. In addition, I understand that none of the following entities provides insurance coverage for my child’s participation in the Kings Sports Centre Summer Camp and that it is strongly recommended that I obtain my own accident and health insurance to cover my child prior to participating: Kings Sports Centre Summer Camp.

In exchange for the use of equipment, materials, supplies and for being allowed to participate in this Program, I hereby release and forever discharge the Kings Sports Centre, and all sponsoring agencies and their members individually and their officers, agents and employees from any and all claims, demands, rights, expenses, actions, and causes of action, of whatever kind, arising from or by reason of any personal injury, bodily injury, property damage, or the consequences thereof, whether foreseeable or not, resulting from or in any way connected with my child’s participation in this activity.
